

# Parental Consent & Minor Use Policy

**Last Updated:** 01/22/2026

National Athlete Index (“NAI,” “we,” “our,” or “us”) is committed to protecting the privacy, safety, and rights of student-athletes under the age of 18 (“Minors”). This Parental Consent & Minor Use Policy explains the requirements and conditions under which Minors may use the NAI platform.

---

## 1. Applicability

This policy applies to:

- Student-athletes under the age of 18
- Parents or legal guardians of Minor athletes
- Any individual creating or managing an athlete profile on behalf of a Minor

By creating or authorizing a Minor account, the parent or legal guardian agrees to the terms outlined in this policy.

---

## 2. Parental or Guardian Authorization Required

Accounts for Minors must be:

- Created by a parent or legal guardian, **or**
- Explicitly authorized by a parent or legal guardian

By authorizing a Minor’s account, the parent or guardian confirms that they:

- Are the legal parent or guardian of the Minor
- Consent to the collection, use, and storage of the Minor’s information as described in NAI’s Privacy Policy
- Understand the nature and purpose of the NAI platform

---

### **3. Information Collected for Minors**

For Minor athletes, NAI may collect and display information including:

- Athlete name, sport, position, graduation year
- Athletic measurables and milestones
- Academic information (e.g., GPA, transcripts)
- Video links and supporting documents
- Recruiting education program completion status

Sensitive academic records and documents are handled with restricted access and are not publicly visible.

---

### **4. Profile Visibility & Controls**

Parents or guardians may control or request changes to:

- Profile visibility (public vs limited)
- Access to academic records
- Uploaded documents and media
- Account deletion or suspension

NAI provides visibility controls intended to protect Minor athletes while allowing appropriate recruiting evaluation.

---

### **5. Recruiting Education Programs & Certificates**

NAI offers recruiting education programs that may include quizzes or knowledge checks.

For Minors:

- Participation in programs is educational only

- Completion indicates understanding of recruiting concepts
- Completion status may be visible on the athlete's profile
- No scores, rankings, or evaluations are displayed

The **NAI Education Certificate**:

- Indicates completion of recruiting education programs
  - Is not a ranking, evaluation, or endorsement
  - Does not guarantee recruiting outcomes

## **6. No Guarantees or Recruiting Promises**

Parents and guardians acknowledge that:

- NAI does not guarantee scholarships, offers, roster spots, or recruitment
  - Recruiting decisions are made solely by college programs
  - Use of the platform does not imply evaluation or interest from any coach or institution
- 

## **7. Parent & Guardian Rights**

Parents or legal guardians may:

- Request access to the Minor's information
- Request correction of inaccurate data
- Request deletion of the Minor's account
- Withdraw consent at any time

Requests can be made through the platform or by contacting NAI directly.

---

## **8. Data Protection & Security**

NAI implements reasonable safeguards to protect Minor data, including:

- Restricted access to sensitive information
- Secure storage of academic records
- Limited visibility to authorized users

While no system can guarantee absolute security, NAI is committed to protecting Minor information responsibly.

---

## **9. Coach Access to Minor Profiles**

Authorized college coaches may view Minor athlete profiles for evaluation purposes only.

NAI does not control or influence how coaches evaluate athletes and is not responsible for recruiting decisions or actions taken by third parties.

---

## **10. Compliance with NCAA Guidelines**

NAI operates in accordance with NCAA bylaws, policies, and procedures.

NAI does not rank athletes, guarantee recruiting outcomes, or influence recruiting decisions.

NAI may update this policy from time to time. Updates will be posted on this page with a revised “Last Updated” date. Continued use of the platform constitutes acceptance of the updated policy.
