

Terms of Service

These Terms of Service (“Terms”) govern access to and use of the National Athlete Index website, platform, and related services (“NAI,” “we,” “our,” or “us”). By accessing or using NAI, you agree to be bound by these Terms. If you do not agree, do not use the platform.

1. Purpose of the Platform

National Athlete Index is a recruiting profile and education platform designed to:

- Allow athletes to present academic and athletic information in a structured format
- Provide recruiting education for athletes and families
- Enable college coaches to evaluate athlete information efficiently

NAI does **not** rank athletes, guarantee recruiting outcomes, or influence recruiting decisions. All recruiting decisions are made solely by college programs.

2. Eligibility & Account Types

a. Athlete Accounts

Athlete accounts may be created by:

- Athletes aged 18 or older
- Parents or legal guardians on behalf of athletes under 18

Athletes and families are responsible for ensuring that all information submitted is accurate and up to date.

b. Coach Accounts

Coach access is limited to authorized college coaches. Certain features may be restricted based on verification or compliance requirements.

3. Accounts for Minors

- Accounts for athletes under 18 must be created or authorized by a parent or legal guardian.
- Parents or guardians are responsible for monitoring the minor's use of the platform.
- NAI may restrict visibility of sensitive academic information for minors.

4. User Responsibilities

By using NAI, you agree to:

- Provide accurate, truthful, and current information
- Maintain the confidentiality of your login credentials
- Use the platform for lawful and appropriate recruiting-related purposes
- Comply with all applicable NCAA rules, policies, and procedures

Users may not:

- Misrepresent identity or athletic ability
- Upload false, misleading, or fraudulent information
- Use the platform to harass, solicit improperly, or spam others
- Attempt to manipulate visibility, evaluations, or access

5. Recruiting Education Programs & Certificates

NAI offers recruiting education programs that may include quizzes or knowledge checks.

- Completion of programs indicates educational participation only.
- Athletes who complete all available programs may receive an **NAI Education Certificate**, displayed on their profile.

- The certificate is **not a ranking, evaluation, endorsement, or guarantee**.
 - Completion does not influence recruiting decisions or require coach consideration.

Athletes may control certain profile visibility settings.

- Public profiles display limited, non-sensitive information.
- Academic records and supporting documents are visible only to authorized users.
- Coaches may view information for evaluation purposes only.

NAI does not control how coaches use information once accessed and is not responsible for recruiting decisions.

7. NCAA Compliance

This recruiting/scouting service has been approved in accordance with NCAA bylaws, policies, and procedures. NCAA Division I football and/or basketball coaches are permitted to subscribe to this recruiting/scouting service.

NAI:

- Does not rank athletes
 - Does not promise exposure, scholarships, or roster spots
 - Does not influence recruiting decisions
